LOT 195 - Headline: **Exceptional Exhibition Grade Engraved and Gold Plated Remington-Smoot New Model No. 2 Revolver with Pearl Grips, Leather Bound Case, and Book.** Caliber: 32 RF. The book incorrectly lists this revolver as a No. 1 in .30 caliber.

LOT 292 - Headline: **52B.**

LOT 336 - Adjustable rear sight.

LOT 362 - Includes two Ruger Law Enforcement Products brochures (1980 and 1982).

LOT 368 - Includes a rare and complete period Thompson spare parts kit.

LOT 399 - Provenance: The Estate of Robert S. Eddy II.

LOT 652 - Condition: 99% plus original gold finish.

LOT 1010 - Except for the "32 Protector" round, all of the cartridges appear to be present and attached.

LOT 1013 - In addition, Phil Schreier, Director of the NRA Museums, confirmed that this rifle was displayed by Dr. Ray House as part of the Ohio Gun Collectors Association display at the NRA Annual Convention in Kansas City, Missouri, in 2001 and won the coveted "Ten Best Arms Award" (medal #388, not currently with the rifle).

LOT 1042 - Rifle will factory letter has having an octagon barrel in .44 caliber, plain trigger, checkered pistol grip stock, half magazine, shotgun butt and casehardened receiver when received in the warehouse on December 9, 1886 and shipped the same day along with an "additional date" of July 24, 1894. It is our opinion that the half magazine was changed out to a full magazine when the rifle was returned to the factory in 1894.

LOT 1047 - Consignor states that he shot .488 lead balls out of this rifle.

LOT 1054 - Headline: **Engraved, Relief Carved, and Silver Accented John Noll Smoothbore Flintlock American Long Rifle.** The dagger shaped marking, initials, and other attributes such as the rectangular patchbox release identify this rifle as the work of John Noll (1747-1824) of Franklin County, PA, who is associated with the Chambersburg School.

LOT 1173 - Includes an original copy of the "New Berne Monument Commission of Providence Plantations: Report made to the General Assembly of Rhode Island."

LOT 1334 - Chokes were not bored by Tom Seitz.

LOT 1335 - Chokes were bored by Tom Seitz.

LOT 1347 - Estimate: 2250 - 3750.

LOT 1357 - Per the consignor the barrels have high grade 3 iron crolle Damascus pattern.

LOT 1384 - Headline: **Exceptional Angelo Bee Master Engraved and Gold Inlaid Belgian Browning 20 Gauge Midas Grade Superposed Shotgun.** Excellent as custom embellished by Master Engraver Angelo Bee, retaining 99% plus blue and gold finishes with limited handling evidence.

LOT 1491 - Additionally, statements from the consignor note that this flamer was used for a segment titled "Flamethrower vs Spider Trench" on the Smithsonian Channel Program "Weapon Hunter"; clips posted online by Smithsonian show the flamer in operation. Condition: Mechanically untested in-house, but successfully fired with an alternate nozzle shield and a hand torch igniter (neither included) during the Smithsonian Channel demonstration.

LOT 1509 - Includes two Ruger Law Enforcement Products brochures (1980 and 1982).

LOT 1586 - Headline: **Extremely Rare, Documented Nickel Plated Indianapolis Police Shipped Smith & Wesson .357 Registered Magnum Double Action Revolver with 5 Inch Barrel, Box and Factory Letter.** The accompanying factory letter lists this revolver with a 5 inch barrel, 1/8 inch Baughman quick draw front sight, 1/8 inch square notch rear sight, Magna stocks, humpback hammer and nickel finish. The letter also states the revolver was part of an order listed as a personal sale of S&W Sales Manager Cy Bassett for 15 Registered Magnums, all in the same configuration, billed at \$35.45 each, and sold to the City of Indianapolis, Training Division, Police Department, Indiana, attn. Lt. E.H. Kruse, Director, Training Division.

LOT 1588 - Headline: **Two Smith & Wesson .44 Hand Ejector Fourth Model Target Pre-Model 24 Double Action Revolvers with 6 1/2 Inch Barrels with Berns-Martin Tooled Double Holster Rig -A) Smith & Wesson .44 Hand Ejector Fourth Model Military Pre-Model 24 Revolver.**

LOT 3015 - Headline: **Second Year Production Winchester Model 1886 Lever Action Rifle with Factory Letter.** The accompanying factory letter states the serial number for this rifle was applied on June 9, 1887, confirms the octagon barrel in .40-82 caliber, and plain trigger, and the rifle was received in the warehouse on July 6, 1887 and shipped the next day.

LOT 3016 - Headline: **Desirable Antique Winchester Model 1873 Lever Action Musket with Factory Letter.** The accompanying factory letter states the serial number for this musket was applied on December 15, 1890, confirms the musket configuration chambered in .44 caliber, and received in the warehouse on January 5, 1891 and shipped on January 26.


