LOT 48 - Has the desirable "first model" receiver featuring the "10 o'clock" screw by the loading gate. The rifle is identified in Robert Renneberg's "Winchester Model 94: A Century of Craftsmanship" (2nd edition) on page 233 where it is cited: "This is one of my favorites: Model 1894 serial number 6242, verified as a first model...It also has one of the rarest of 1894 options, a casecolored receiver!" As published in the summer 2016 issue of The Winchester Collector, this rifle is listed by serial number in Bob Kassab and Brad Dunbar's Model 1894 survey as one of only 155 Model 1894 rifles that came out of the factory with a casehardened receiver.

LOT 60 - Headline: Documented Special Order Winchester Deluxe Model 1894 Lightweight Lever Action Takedown Rifle with Factory Letter. C& R long gun.

LOT 3224 - This revolver is featured in the article "Seward: The Man an His Gun" by Jim Earle in the included copy of "The Gun Report" from March 1975. Scans of a letter from Seward to Samuel Colt are also included. The letter is dated October 28th, 1861, and asks Colt to sent the Department of State a list for the costs of his best ornamented revolvers.

LOT 3578 - Per the consignor, this shotgun was previously owned by Judge Edwin A. Robson (1905-1986), the consignor's grandfather. Robson was the chief judge of the U.S. District Court for the Northern District of Illinois in 1970-1975 after being nominated to the court by President Eisenhower in the late 1950s. Among his noteworthy decisions was ruling that it is not disorderly conduct to argue with a police officer. His legal career began back in the late 1920s. In 1945, he was elected to the Superior Court of Cook County and became chief judge of the court in 1950. The following year, he became a justice on the Appellate Court of the 1st District of Illinois.

LOT 3682 - Two medallions and keys are included. This Winchester-Colt commemorative set is listed in the official "Curio or Relics List" by the ATF.
